



### FINANCIAL ASSISTANCE APPLICATION

Financial assistance is available to state employees and employees of transportation related authorities whose combined family gross income is \$85,000 or less after deducting \$2,500 times the number of dependents in the household. Assistance will be given on an annual basis and deducted weekly from the cost of care. Financial assistance will be awarded based on funding and on a first-come, first-served basis.

To apply for financial assistance an application should be completed for each child and be submitted to the Executive Director with your most recent signed federal income tax return(s) and W-2 form(s) for all contributing members of the household.
